



Canadian Data Exchange Survey

Background Information

This national survey on data exchange practices is being led by the Association of Registrars of the Universities and Colleges of Canada (ARUCC). Joanne Duklas of Duklas Cornerstone Consulting is the primary investigator for the research. The findings will be used to support three projects:

- The ARUCC Groningen & Student Mobility Project
- The Data Exchange Project funded by the British Columbia Council on Admissions and Transfer (BCCAT) conducted in partnership with the University of Victoria
- A Data Exchange Project funded by the Ontario Council on Articulation and Transfer (ONCAT) conducted in partnership with the Ontario colleges' Council of Registrars, Admissions, and Liaison Officers (CRALO) and the Ontario University Registrars' Association (OURA)

Who should complete the survey?

- Registrarial experts with knowledge of systems
- IT staff with expertise in electronic student data exchange policies, practices, and technology infrastructure
- Staff with expertise in international assessment practices who would have knowledge of international organizations involved in electronic exchange of student data

The survey is being distributed to registrarial and systems leaders at post-secondary institutions and allied organizations across Canada. Confidentiality and Privacy

Data from this research will be reported anonymously; quantitative data will be reported at the aggregate level. Respondents personal information will not be shared; survey results will be shared with ONCAT, BCCAT, and ARUCC.

Other Comments

This is an operational survey to assist with identifying current and recommended practices from experts at Canadian post-secondary institutions and allied organizations. Findings and subsequent analysis will be supported by literature and website research and interviews with experts at post-secondary institutions and allied organizations.
